New Business

Railyard Cleanup -

As part of the Great American Cleanup and Keep Santa Fe Beautiful, SFRCC is participating in Santa Fe's Spring Cleanup on Saturday, April 15, 2023, from 9 a.m. – 12 p.m. To participate a notice has been sent to all tenants and the SFRCC Board. The City of Santa Fe is providing t-shirts, trash bags and gloves. Everyone is asked to meet at the water tower at 9am.

In-Person SFRCC Board and Committee Meetings

February 2023 Draft Financials

- Report from Finance Committee meeting on 04.05.23 Balance Sheet, Income Statement & Budget Report were reviewed.
- Cash balance continues to increase with an expected year-end balance of approximately \$300,000.00.
- Draft budget will be reviewed at the May Finance Committee meeting.
- Met w/Tony Ornelas from Enterprise Bank and assured us the bank is safe.
- Transfer from Enterprise Bank will be made to the NM Bank and Trust account to make the City of Santa Fe payment.
- SFRCC has been approved for credit cards with NM Bank & Trust. Wells Fargo Credit Card accounts will be closed when NMB&T cards are activated.
- SFRCC Corporation Resolution Authority to Conduct Business will be submitted to Enterprise Bank & Trust to allow access to Christine Robertson and Valarie Lyon Vigil.
- Payroll is over budget due to payouts of former employees and payroll schedule changes.
- Audit is on schedule and essentially done, will review at May Finance Committee meeting.

Leasing & Design Committee Update

- Altar Spirits signage rebranding to "As Above So Below", City provided the approval letter.

2023 EVENTS UPDATE (Provided by Christine Robertson, Executive Director)

- <u>PPP Update (Christine Presented):</u> The 2023 PPP document has been signed by Christine, Regina Wheeler and Sam Burnett. It is now at the City Attorney's office and after she signs it, it'll go to the City Manager for the final signature.
- <u>IFAM Update</u>: City has met with IFAM and have given approval for IFAM to use Warehouse 21 during the market for a hospitality location for their volunteers, artists and workers.
- <u>Farmers Market License Agreement:</u> The agreement has been signed and were happy about the \$2.50/ event fee and the \$10/booth fee.
- <u>Skyrail License Agreement</u>: The agreement has been signed and paid the \$1,200 fee. The agreement includes the West Casitas and primarily using track one. SFRCC has received their schedule.
- <u>Madeline School for the Arts:</u> Art classes on the plaza Monday Friday next and again in May.
- Railyard Park Conservancy: Saturday, April 22, 2023, hosting Earth Day includes two (2) SITE openings and the humans bird nest public art project.
- <u>Indigenous Ways Events</u>: Events scheduled monthly, first one on May 5th.

- <u>Girls Scouts of America</u>: Arts & Crafts show on Saturday, May 5th in the Railyard Park & will collaborate with the artists market.
- All events are posted on the Website, Facebook and Instagram. Notice about IFAM will be sent to the tenants in the next couple of weeks.

- Railyard Security Update As of Monday, April 10, 2023, Condor security is on overnight patrol, email update was sent to tenants. Overnight will continue through June.
- Sky Coffee has been having weekly break-ins, breaking in through windows, they have security cameras, safe stolen (no cash).
- Tenants may need to consider a group plan after the overnight patrols expire.
- City issuing an RFP for Warehouse 21.
- Parcel B1 In discussions with several groups but nothing substantial at this point.
