Oscar Rodriguez, Treasurer & Christine Robertson, Executive Director reported on the April 2023 Financial Report.

#### 2021-2022 Draft Audit

Jake Dopson, CPA/Owner and Elijah Esquivel, Audit Senior Manager from Pulakos CPA, provided an overview of the 2021-2022 Draft Audit.

- Pulakos performed annual financial audit and prepared annual 990 for FY2022.
- No Management letter issued for June 30, 2022.
- No instances of fraud, opinion shopping or improper activity noted during the audit.
- Audit Adjustments, Violet Crown Net Present Value and City of SF Deferred Lease Liability.
- No accounting standards changes.
- Issued an Unmodified "clean" opinion.
- Financial Trends long lease liability with the City of SF is generated by the accounting rules, not by the economics of the lease liability.

**Acceptance of the 2021-2022 Audit,** was unanimously approved, motion by Rosemary Romero, 2<sup>nd</sup> by Oscar Rodriguez.

## Eun Hong – Insight CPA report

- New accounting standards the balance sheet will need to reflect the liability and asset of the entire lease with the City of Santa Fe and each tenant lease.
- SFRCC will operate on a cash basis until year end then transfer to an accrual basis.

# **April 2023 Draft Financials**

- Report from Finance Committee meeting on 06.07.23.
- Balance Sheet, Income Statement, Budget Report and Cash Flow were reviewed.
- Financial review Year to date income exceeds budget by \$33,052. Surveys an unbudgeted expense. Snow removal and dump fee expenses were more than budgeted.
- Cash balance continues to increase. Interest income increased from balance transfer from NMB&T to Enterprise.
- Christine will review the CAM balance and report back to the Board.
- SFRCC's cash position is strong, there are no anomalies in the financial statements.
- SFRCC is ahead of the budget in both revenue and expenditure.
