New Business

Board of Directors Members Election

Steve Robinson requested a motion to revise the previous motion of David Vlaming's resignation to "retirement", the motion was unanimously approved, motion by Rosemary Romero, 2nd by Chris Calvert.

Homeless Coalition Update

Christine provided an update from Project Moxie, they're funded by the St. Vincent's Foundation. Currently looking for property to place their heated tents, like their 7 sites in Denver and are working to purchase a hotel on Cerrillos Road. They have an 80% success rate of getting individuals into permanent housing.

Jenn Lopez, Project Moxie contact, former City of Santa Fe employee.

Oscar suggested that SFRCC continue their involvement with the group and asked J. Lopez to provide a complete overview of the process to determine SFRCC's participation. He requested that the Board ask the Executive Director to continue participating and bring information back to the Board.

Rosemary added to Oscar's request that Christine set up a meeting with Anchorum's Executive Director to discuss their funding to homeless communities.

Approval of Rose Starsmeare Subtenant (former Yares Space)

Christine reported that Sibylle Szaggards Redford Fine Art is interested in the space formerly occupied by Yares and asked for Board approval.

The motion to accept the Subtenant Lease for Sibylle Szaggards, was unanimously approved, motion by Chris Calvert, 2nd by Bob Dunn.

Retirement Party

Steve reported that Bill Banowsky has offered to host a party for Richard & Sandy's retirement in mid to late January. It will be a party for Richard, Sandy & David Vlaming and the venue will be held at Nuckolls.

Christine is assigned to reach out to Richard, Sandy and David on a date and coordinate with Bill at Nuckolls for a date in mid to late January.

October 2022 Draft Financials

- SFRCC's cash position is very strong, there are no anomalies in the financial statements.
- SFRCC is ahead of the budget in both revenue and expenditure.

Audit Status

- Pulakos has been selected for the Audit and have a lot of Non-Profit Clients.
- Auditor's had a site visit on 12.06.22 and immediately began requesting documentation, working on a February deadline to complete the audit.

- Sandy gave an overview of the 2022 Public Use Events that were permitted. Fundraising Events increased in 2022.
- Fundraising November's Cranksgiving event raised 5.5 tons of food and SHAP raised \$5,000
- Community Service SF Farmers Market held to blood drives, NMDOH issued 15,233 COVID vaccines.
- Sandy provided a report of all events permitted since 2008.
- Christine provided a recap of the 20th Anniversary Celebration, costs and guest list. A press release will be issued, that'll include photos of the event and the video presentation.

- Nuckolls Update Leasing Committee provided some conditions, along with the City's recommendations. Approval letter will be given to Peter Dwyer for review.
- HH Update Shoofly Station apartments, expecting to open in February or March.
- Market Station Update H Bar no longer a potential tenant. Restoration Pizza will not be expanding into Flying Star space. Two spaces of 3,000 square feet are available at Market Station.
- Second Amended & Restated Lease & Management Agreement Update Still being reviewed by legal and expect it back in January.
- Warehouse 21 & Depot Update Waiting on final documents back from the City for Steve's signature, it'll go back to the Governing body and placed on the January docket.
- Condor Security Going well, homeless starting to occupy the parking garage. Christine meeting with Condor on 12.14.22 to discuss parking garage patrol schedule.
- City of Santa Fe Property Development Manager Hired a new Property Development Manager, Tim Farrell, he'll be SFRCC's new point of contact.
- 2023 Board of Directors Meeting Schedule, included in packet.
- 2023 SFRCC Holiday Schedule, included in packet.
- Ron Pacheco Concerns regarding curb cut of "non-tenants" in Baca. Chris Calvert, requested that SFRCC determine what other properties are on the easement.
